AN ORDINANCE MAKING APPROPRIATIONS FOR THE CORPORATE AND OTHER PURPOSES OF THE VILLAGE OF YATES CITY, KNOX COUNTY, ILLINOIS, FOR THE FISCAL YEAR COMMENCING ON THE 1ST DAY OF MAY, 2024, AND ENDING ON THE 30TH DAY OF APRIL, 2025

## BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF YATES CITY, KNOX COUNTY, ILLINOIS:

Section 1. That the following sums, or so much thereof as may be authorized by law, are hereby appropriated for the corporate and other purposes of the Village of Yates City, Knox County, Illinois, to defray all necessary expenses and liabilities of said Village of Yates City, as hereinafter specified, for the fiscal year commencing on the 1st day of May, 2024, and ending on the 30th day of April, 2025.

Section 2. The sums of money not immediately needed shall be invested in Tax Warrants or Bonds of the Village of Yates City, or in securities of the federal government, or in federally insured deposits or savings accounts or certificates of savings and loans and banks.

Section 3. The said several sums of money are hereby appropriated from monies received and to be received by the said Village of Yates City from all sources. Any unexpended balance of any item of any appropriation made by this Ordinance may be expended in making up any insufficiency in any other item of appropriation made by this Ordinance.

Section 4. If any item, or portion thereof, of this Ordinance is for any reason held invalid by a Court of competent jurisdiction, such decision shall not affect the validity of the remaining portion of such item, or the remaining portion of this Ordinance.

Section 5. All unexpended fund balances for the fiscal year ending on the 30th

day of April, 2024, are hereby appropriated for the purposes herein set forth.

<u>Section 6</u>. This Ordinance is hereby ordered to be published in pamphlet form by the Yates City Village Clerk, who is ordered to keep at least three copies hereof available for public inspection in the manner provided by law.

<u>Section 7</u>. This Ordinance shall take effect and be in force from and after its passage, approval and publication, as provided by law.

<u>Section 8</u>. By no later than July 31, 2024, the Village Clerk is hereby authorized and directed to file a certified copy hereof with the Knox County Clerk.
